1. Introduction

At Jeff Alldridge for Idaho Falls (“jeff4if,” “we,” “us,” or “the Campaign”), we are committed to respecting and protecting your privacy. This policy explains what information we collect, how we use it, how we keep it safe, and details about our text messaging (SMS) program.

2. Information We Collect

We may collect the following information when you interact with our campaign:

- Name (first and last)
 - Email address
 - Phone number (including mobile number, if provided)
 - Mailing address (optional, for donations or volunteering)
 - Any other information you choose to provide (e.g., questions or feedback)

3. How We Collect Information

We collect information when you:

- Fill out forms on our website (e.g., endorsement, contact, volunteer, or donation forms)
 - Opt in to receive SMS/text messages from our campaign
 - Communicate with us by phone, text, email, or in person

4. How We Use Your Information

We use your information only to:

- Send you campaign updates or respond to your inquiries via SMS/text message, email, or phone call (only if you have opted in)
 - Inform you about campaign events, news, or volunteer opportunities
 - Process donations (if you choose to give)
 - Comply with election and campaign laws

5. Information Sharing

- **We never sell or share your information for marketing, promotional, or unrelated business purposes.**
 - We may share your information with trusted service providers (such as donation or texting services) only as required to operate our campaign. These partners are contractually required to keep your information confidential.
 - **SMS and mobile opt-in information will never be sold, shared, or transferred to any third party except as needed to deliver campaign text messages or as required by law.**
 - We may disclose information as required by law (such as to comply with subpoenas or government requests).

6. SMS/Text Messaging Terms and Conditions

You may receive up to 4 messages per month. Message and data rates may apply. These SMS messages are sent by Jeff Alldridge for Idaho Falls (jeff4if). Text STOP to unsubscribe. Text HELP for assistance. Your mobile opt-in information will never be shared with third parties.

- **Types of messages:** If you opt in, you will receive SMS/text messages about campaign updates and responses to your inquiries from Jeff Alldridge for Idaho Falls.
 - **Message frequency:** Message frequency varies, but you may receive up to 4 messages per month.
 - **Message and data rates:** Message and data rates may apply.

 - **Opt-out instructions:** You may opt out of texts at any time. Text STOP to unsubscribe.
 - **Help instructions:** Text HELP for help or assistance.
